I am writing this submission in support of the proposed reform of the fire services for the following reasons:

Victoria has been working under a system that struggles to keep up with the demands of modern Victoria. Things have changed dramatically since 1958, the growth and spread of communities and suburbs, the hazards and risks of our innovative industries and the booming population that is ever growing in Victoria.

As Victoria changes all the essential services have to change with it. Matching the growth with the service delivery Victorians expect and deserve. The constraints of the MFB and CFA acts as they stand, that have worked well in the past, and were appropriate when written, are now failing to keep up and match the ever changing face of Victoria.

In my opinion, the successful protection of Victoria is not based on sticking to what has always been done, but based on an organisations ability to adapt. This is not a bad thing, this is evolution.

If we look at the work that has been done on documents such as the OH&S act of 2004 since its first adaption as a modern occupational health and safety legislation in 1985 the document has changed and shifted to cover short falls and evolved over the years to provide the best regulations and guide lines to protect Victorians.
