## RE: Victorian Fire Services Reform and Legislation.

I write to you in support of the Fire Services Reform currently being proposed by the state government.

As an MFB fire-fighter I look forward to hopefully working closer with current CFA career staff members in the future. I am currently stationed at Oakleigh Fire Station and was previously stationed at Vermont South. On a number of occasions we have turned out with CFA career members and the level of professionalism and respect shown has been immense.

When we have turned out with CFA appliances I am left astonished that these areas are considered country when they are clearly built up urbanised suburbs. I understand that in the past many of these areas would have been rural but times have changed and I firmly believe that we need to modernise our fire services and move on from an out-dated model.

When census data is released showing that Melbourne is the fastest growing city in the country I can't help but wonder what this state will look like in another 10 or 20 years with the urban crawl quickly expanding. It is imperative that changes be made sooner rather then later in order to prepare for the major changes coming to this state. I have attached at the bottom of this page (Victoria in future, 2016) a table that shows the projected population growth in regional areas over the next few decades. If the projections are correct the population of regional victoria will almost double by 2051 compared to 2011 further illustrating the need for a modernised fire service.

There will always be a need for volunteers and the job they do in rural and semiurbanised areas is vital. I appreciate that the new reforms will allow current volunteers at integrated stations to remain volunteering at those stations. The work volunteers perform is vital but they cannot always be available to quickly respond due to family, work or other commitments. It is therefore vital that we as a state continue to expand the number of full time career fire-fighters as our state continues to grow. I think it is fantastic that both volunteers and career staff will be covered by presumptive cancer legislation if these reforms pass and it will benefit generations to come.

Please endorse the FRV and bring our fire services into the 21st century.
