- 2. I live in Rosebud and work in CFA District 8.
- 3. I have been deployed operationally both interstate and internationally to assist other fire agencies.
- 4. CFA is my third fire service having previously been employed as a private industry Firefighter with Transfield Fire & Rescue (1999 2005) based at HMAS Cerberus and as an Aviation Firefighter with Aviation Rescue & Fire Fighting service (2005 2008) based at Melbourne Airport.
- I also volunteer in my community with Dromana, where I commenced my service with CFA in 1994. In my capacity as a volunteer with Dromana, I have served as a Lieutenant for 8 years (1996 2004) and a Captain for 4 years (2004 2008).

- 6. I am writing this submission in support of the proposed reform of the fire services for the following reasons:
 - The legislation will provide career and volunteer firefighters who work within hazardous environments, in the service of others for the purpose of protecting life and property, with an ability to access compensation for work related cancers contracted as a result of this service.
 - The reform will allow CFA to operate as the current Act (Country Fire Authority Act 1958) requires. The current Act only allows for Volunteer and Permanent Brigades, it has no provision or definition for an "Integrated Brigade".
 - The reform will allow for independent review of response areas to ensure the community
 receives the fire service response standards that are required. As an Officer in Charge of a
 volunteer brigade it was my experience, that it is a constant battle to ensure that sufficient
 numbers of appropriately qualified operators are available to meet the requirements of the
 modern fire service. This was especially true during high fire danger days where it is
 extremely important to ensure crewing of all appliances (Pumper, Tanker and Rescue) on
 station. To ensure sufficient fire coverage we utilised to skills and availability of our
 neighbouring brigade which has career staff on duty.
 - The reform will allow all career firefighters to be employed by one emergency service. This
 provides great opportunity for Victoria to increase the operational efficiency in emergency
 response through combining collective knowledge and effort in improving operating
 processes, equipment, training and response.
 - The reform will allow the Victorian Fire Service community to move forward to a positive future. The current environment within the fire service is polluted, with political propaganda and agenda. The constant attacks upon career firefighters by media outlets has left many discouraged and disillusioned. My personal experience has been that of withdrawal, depression and shame as a result of these constant attack. The reform offers the opportunity for the fire service community to develop a positive future.
