Commonwealth Women Parliamentarians (CWP) Workshop

Champions for gender equality: achieving equal participation in Commonwealth parliaments.

As an executive member of the Commonwealth Parliamentary Association (CPA), Victoria branch I was privileged to attend the 'Champions for gender equality: achieving equal participation in Commonwealth parliaments' workshop in December 2023.

Also in attendance was the CPA Vic Branch CWP Representative, Juliana Addison, Member for Wendouree. The only other Australian representatives were Deb Frecklington, Member for Nanango and Corinne McMillan, Member for Mansfield from the Queensland parliament.

The CWP is a network of women Members of the Commonwealth Parliamentary Associations Parliament and Legislatures. The network extends to 180 Commonwealth national and sub-national parliaments and represents some 3,000 women MPs.

The Champions for gender equality workshop was held at the Serena Hotel, in Dar Es Salaam, Tanzania 6-8 December 2023.

African countries were well represented with women attending from Botswana, Eastern Cape (South African province), Kenya, Mozambique, Namibia, Nigeria, Rwanda, Sierra Leone, South Africa, Tanzania, and Zambia. Other attendee were from Belize, Canada, Jersey and Kerala (India).

Whilst a detailed workshop program is available, I will highlight a couple of areas.

The role of men as gender champions got some airtime. There were also a number of men in attendance from Eastern Cape, Kerala, Namibia, Tanzania, South Africa & Zambia. For women to press forward with equal representation, it is important that there are male champions in each parliament to help push the cause. Nevertheless men are needed to be on board to make a difference.

In Botswana although they have some female representation it was discussed that the 'men in power' don't have confidence in woman, which was unfounded. It was noted that Tanzania is led by a woman (not elected, the President died 3 months into his term and as VP she is the constitutional successor.

There was strong encouragement for parliaments to establish a 'women's caucus' across all parties to raise issues, support each other and discuss ideas to increase representation. Violence against MPs was a concern and in Africa it appears smear campaigns were more often against women.

Different approaches to gender quotas were noted. Of particular interest was the differing constitutions across countries to increase women's representation. Some countries have designated seats that can only be contested by women. In Kenya for example, there are 7 seats that can only be contested by women. Whilst this guarantees some level of female representation, women who want to contest other seats are strongly discouraged to so and instead suggested to go for the women only seats which limits the overall penetration of women across the country. Sierra Leone also have women only seats.

Publications prepared by CPA/CWA and made available relevant to the workshop were 'Gender sensitising parliaments guidelines: standards and a checklist for parliamentary change' and Gender sensitising parliaments: a seven-step field guide.

My trip was funded by CPA Vic branch, with assistance from Parliament of Tanzania for airport transfers in Africa. I upgraded to Premium economy on the Melbourne to Dubai leg using my parliamentary travel allowance.
