SPORT

1. Regarding the funding of \$300,000 related to the Integrity in Sport program in the 2014-15 Budget, please indicate how much of that money has been expended to date.

(Page 6 of the Sport portfolio transcript)

The Integrity in Sport program was initially funded for one year only (2014-15). However, the Department has carried over the unexpended component of the original funding into the 2015-16 financial year to continue work on building the integrity capacity of key sports that may be vulnerable to cheating and match manipulation. The project was therefore extended beyond the initial 12 month timeframe.

As at 31 May 2016, \$293,098 has been expended or committed towards the program.

2. Please provide further information related to the development of netball courts in inner Melbourne.

(Page 11 of the Sport portfolio transcript)

The commitment to develop 64 competition standard netball courts in the inner city councils of Melbourne, Yarra, Darebin and Moreland aims to strengthen the supply of outdoor courts and increase the opportunities for women and girls to access netball in Melbourne.

The commitment will see 64 courts developed in a range of settings including Council recreation reserves, parks, existing sites and in schools across the area. The Department is working closely with the Cities of Melbourne, Yarra, Darebin and Moreland to identify suitable sites for court development. This is in addition to other stakeholders such as the Metropolitan Planning Authority, the Department of Education and Training, local schools and Netball Victoria – who will drive participation increases with access to new courts.

So far, construction of three courts has begun at the Darebin Community Sports Stadium in Reservoir, with an additional 61 courts in the final phases of being identified for development over the next two years.

These courts are being identified through a collaborative planning process involving all relevant stakeholders and by engaging specialist leisure planning experts.

The next phase of planning work will be to develop site specific tender documentation and costs for each project to enable their delivery through the relevant program partner.

3. Regarding the \$46.4 million of funding related to the Community Sports and Events output, please provide a full breakdown of this money in terms of the Better Indoor Stadiums Fund, the country football and netball program, the significant sporting events program, Moorabbin Reserve and the relocation of Elsternwick and Carrum Downs pavilions.
