

Statewide Maternal and Child Health services

Every child and family has access to Maternal and Child Health services in Victoria to ensure they have the best start to life.

Giving children the best possible start in life

The 2024-25 State Budget invests \$28.8 million over three years to meet increased demand for universally delivered Maternal and Child Health (MCH) services.

This builds on 2023-24 State Budget investment for MCH and Early Parenting initiatives, this included the More Support for Mums, Dads and Babies package, resulting in more practical support to children and families across Victoria.

Since 2019-20, the Victorian Government has invested \$19 million ongoing in operational funding to create a network of 13 Early Parenting Centres (EPC) across the state.



Early Childhood Education

The **\$14 billion** Best Start, Best Life reforms are setting the standard for the nation on early childhood education.

Giving children the best possible start in education

- > The 2024-25 State Budget invests \$128.6 million in Best Start, Best Life to continue delivery of nation leading reforms:
 - » Delivering Three-Year-Old Kinder
 - » Continuing to deliver Free Kinder
 - » Pre-Prep begins in 6 local government areas
 - » First 4 Early Learning and Childcare Centres set to open in 2025 followed by 14 more in 2026

This brings the total investment in Early Childhood Education and Care to over **\$8 billion since we have come to Government,** including **\$3.6 billion** allocated to early childhood infrastructure.



Children and Family Services

In 2024-25, overall investment for child protection and family services is **\$2.1 billion**, an increase of **46.5** per cent since 2019-20.

Victoria has the lowest rate in the nation of all children and young people in care services.

Early intervention to keep families together and safe

2024-25 State Budget Investment

Nearly \$198 million in early intervention and family reunification to continue to keep families together and children safe.

Since 2020-21, The Family Preservation and Reunification Response service model has helped more than 4,900 families – estimated to have kept more than 200 children, including over 50 Aboriginal children, safely at home with their parents, compared to previous placement prevention programs.

More than 60 per cent of families accessing Early Help Family Services demonstrated improvements in parenting self-efficacy over time engaged in early help.

Jointly with the Disability portfolio funding \$14.1 million in 2024-25 to continue supports for children with disability and their families, including Family Services Disability Practitioner program and parenting programs.



Protecting our most at-risk children and young people

> The 2024-25 State Budget invests \$374 million over four years for child protection and family services, including:

\$38.4 million to improving outcomes for children and young people in home-based care, including ongoing funding for the Care Support Help Desk and Care Hub

\$128.2 million to continue critical functions of Child Protection and residential care workforces including \$1.7 million to continue building and documenting the evidence-base for Aboriginal-led child and family services

This builds on significant 2023-24 investment for Aboriginal children and families, children in care and housing for young people leaving care.

> Since 2019-20, **\$4 billion** has been invested in the child protection and family services portfolio over five years.



Historic apology to victims of historical physical and emotional abuse and neglect in institutional care

- > The 2024-25 Budget will invest **\$165 million** for a redress scheme for these Victorians recognising the ongoing impact of their experiences.
- In February, the Victorian Parliament delivered a historic apology to victims of historical physical and emotional abuse and neglect in institutional care before 1990.
- No amount of money can ever make up for what happened, but this significant investment is designed to go some way towards acknowledging the actions of the past.
- Advance redress payments of \$10,000 are available to people who have a terminal or critical illness and meet the nominated criteria. These payments will be available until the scheme commences.
