




## **Court Services Victoria**

1 July 2014




Independent statutory body providing the administrative services and facilities necessary for the Victorian courts and VCAT to operate independently from the executive branch of government



Victorian courts and VCAT have a clear and important responsibility to administer justice fairly, transparently, impartially and with integrity


# **One Courts Group**

# **Key operations**

CSV staff continue to support the delivery of court and tribunal services across the state



Manages **78** court and tribunal facilities across metropolitan Melbourne and regional Victoria including 57 owned facilities

CSV's cost of operations to support all Victorian courts and tribunals including salaries for court staff, judicial officers and VCAT members, court security, facilities management, IT and transcriptions services.



Supports **500+** judicial officers and VCAT members



Employs **2,900+** VPS staff across courts, tribunals and administrative and corporate services

# Court and tribunal key achievements in 2023-24

- Overall pending caseload reduced by 14%
- Criminal clearance results County Court 105%, Magistrates' Court 113% & Children's Court 108%
- VCAT clearance rate 114% and pending Residential Tenancies matters reduced 54.3%
- MCV criminal on-time case processing increased by 22% on 2022-23 result
- 245,000+ Family Violence hearings and 130,000+ Family Violence Intervention Order hearings
- 80% Family Drug Treatment Court participants achieved reunification with their children
- 17 Drug Court participants graduated
- New Assessment and Referral Courts commenced at Bendigo, Ballarat and Heidelberg
- 116 Children's Weekend Online Remand hearings (+22% on 2022-23)
- 1,525 Koori Court matters finalised across County, Magistrates' and Children's Courts
- 3 new Koori Courts opened at Bendigo, Echuca and Heidelberg
- 3 CMS releases now live with 200,000+ eDocs generated
- 2,400+ Supreme Court livestreams supported by the eCourts team
- 200 self-represented litigants supported in Supreme and County Courts

# Court developments improving access to justice

#### **Dandenong Children's Court - opened in June 2023**

- 3 courtrooms specifically designed for Children's Court cases
- A specialist Koori Court
- Court purpose-built with critical safety features for vulnerable children and young persons
- Over 2,700 matters finalised:
  - > 1,450+ Child Protection
  - > 1,100+ Criminal
- > 190+ Intervention Order applications
- 600+ Family Violence Intervention Orders heard.



# New court and tribunal developments

# Specialist Family Violence Courts – Dandenong opened in February 2024

- Security upgrades completed in December 2023
- 5,221 Family Violence Intervention Order hearings since commencing

#### **New Wyndham Law Courts**

Construction is on-track to be completed in early 2025 and on budget

#### **VCAT CBD Accommodation**

- 300 LaTrobe Street site secured in 2023-24
- 24 hearing rooms, 17 mediation rooms and 20 Audio Visual suites
- Modern, technology-enabled facilities will optimise tribunal operations



## **CSV Self-Determination Plan**

#### **Koori Engagement and Consultation Framework**


- In 2023-24, the Framework guided the Courts Group in its:
- engagement with Traditional Owners and Koori Community in establishing the Bendigo Law Courts
- expansion and improvement of Koori programs including proposals for the Wyndham Law Courts

#### **Boosting Koori Employment**

- 5% Koori employment rate including 105 Elders and Respected Persons who sit on Koori Courts (surpassing CSV's minimum target of 3% by 2025)
- 20% of Koori staff are in senior leadership roles

#### **Cultural Immersion Program**

- 240 staff completed cultural awareness training
- 45 participants attended 'On Country' immersion programs
- 33 managers of Koori staff completed Cultural Safety Training



# Workplace safety and culture

#### **Review of Sexual Harassment in Victorian Courts**

An independent audit found CSV has implemented all 16 recommendations, including two currently in progress.

- Education improvements include:
  - > training on new positive duty under amended Sex Discrimination Act 1984 (Cth)
  - intersectional gender inequality and compounded disadvantage
  - identifying risks, responding to incidents and supporting others as active bystanders.

### Prioritising health, wellbeing and safety

#### Initiatives include:

- > Expanding Contact Officer Network remit to support employees experiencing family violence
- Critical Safety Risks Project underway
- Dedicated physical and psychological safety teams identifying and mitigating risks
- Evidence-based resources to inform standard method for identifying, assessing and managing psychosocial risks, including vicarious trauma.

# Managing budget pressures

CSV's savings initiatives aim to manage cost pressures while minimising impacts on frontline services

#### Costs pressures in 2023-24 include:

- court security, facilities management, transcription and IT services
- vital repairs and maintenance spend to support ageing assets
- cyber-security incident in December 2023 leading to unforeseen expenses.

#### CSV's savings initiatives include:

- a 33% reduction in consultant and contractor expenses
- actively managing vacancies and recruitment
- Courts Group corporate consolidation program commenced to increase collaboration, streamline processes and reduce unnecessary duplication.
