Re: Victorian Government Submission to the Economy and Infrastructure References Committee's Inquiry into Commonwealth Payments to Victoria

The Committee's Secretariat received the Victorian Government's submission to the Inquiry into Commonwealth Payments on Thursday 28 June 2012, almost three weeks after submissions had closed.

The Committee has not yet had an opportunity to meet to consider the submission, however, it has come to my attention that an article written by John Ferguson was published in *The Australian* newspaper on Monday 2 July 2012 which discusses and quotes extensively from the Government submission, as well as offering quotes from the Treasurer on the matter of Commonwealth payments to Victoria.

It is very discourteous to the Committee that information provided in the submission has been made public prior to it being accepted as a submission. It is particularly disappointing given that the information was received late from your Department but has then almost immediately been released publicly by the media, prior to the Committee being able to consider the submission.

As Chair of this Committee, I seek your advice as to whether anyone in your Department released the submission to *The Australian* prior to it being published by the Committee. If so, I request that you advise me who authorised the submission being released to the media and provide an explanation as to why this was done.

The Committee will consider in due course whether to accept the Government's submission or treat it as correspondence, given it was provided after submissions had closed. I look forward to receiving your response on the matters outlined above.

Thank you for your correspondence of 5 July 2012 regarding the Victorian Government's submission to your Committee's Inquiry into Commonwealth Payments to Victoria. I appreciate the opportunity to clarify the position of the Department and Treasury and Finance (DTF).

A whole of Victorian Government submission to the Inquiry was selected to provide the most considered possible input to the Committee's work. It is regrettable that delays in finalising this coordinated response meant the submission could not be provided to the Committee until after the requested date for provision. I understand that DTF officials made contact with the Committee Secretariat to highlight and explain these delays.

I note that the submission was provided to the Committee on 28 June, and was referenced in The Australian newspaper on 2 July. The submission was later placed on the DTF website, which is the regular practice of the Victorian Government when making submissions to external inquiries. However, I can advise that no DTF official was authorised to release the submission to The Australian newspaper, and to my knowledge no DTF official has had any contact with the media on this matter.
