



Impact of Electoral Boundary changes


- Relocation of Electorate Offices

- Increased cost of EO rentals, salaries, goods and services purchased




Precinct Rent and Utilities Expense Trend






IT Leasing & Data Comms. Expense Trend

- Ground Floor Members Accommodation Phases 1 and 2
- Security Fence Upgrade (Parliamentary Reserve)
- Conducted bi-annual stone condition assessment and structured future stages of stone restoration






