DELWP's service delivery structure

DELWP consists of six groups working together to support our Ministers and portfolio partners:

- Land, Fire and Environment
- Planning
- Water and Catchments
- Local Infrastructure (including Local Government)
- Regional Services
- Corporate Services

DELWP's **regional service delivery** model is based on local decision making to optimise service outcomes and relationships with local stakeholders, agencies and communities

DELWP profile

- Employs approximately 3,000 staff based at 102 locations across Victoria
- Manages 8.3 million hectares of public land in partnership with portfolio agencies, including Parks Victoria
- Owns and manages \$2.1 billion of other assets, including
 - 40,000km of roads and tracks
 - Office buildings, depots, public toilets, recreational facilities
 - Firefighting and road maintenance equipment
 - Crossings, water bores and mobile plant

2014-15 Key outcomes

Sustainable and effective local government

- Developed a rate capping system, now being implemented, to manage council rate rises
- Developed new measures, subsequently introduced the *Local Government Amendment (Improved Governance) Act 2015* to strengthen council governance and reduce councillor misconduct
- Developed the Know Your Council website – a dedicated website providing insight into the performance of councils via 66 different and diverse measures of financial and operational performance – launched in November 2015

2014-15 Key outcomes

Planning, building and heritage

- Commenced the refresh of the metropolitan planning strategy *Plan Melbourne*
- Released the *Better Apartments* discussion paper
- Continued to deliver effective planning and heritage services including:
 - determining 452 planning scheme amendments
 - issuing 984 heritage permits
 - assessing 44 places or objects for the Victorian Heritage Register
 - reporting annually on residential and industrial land supply

2014-15 Key outcomes

Environment and Climate Change

- Completed 670 planned burns (234,614 ha)
- Responded to 1,149 fires on public and private land
- Led the development of a Climate Change Adaptation Memorandum of Understanding between Victoria's state and local governments
- Provided \$7.44 million in funding to Victorian Landcare groups, resulting in protection and enhancement of 1,600 hectares of revegetation
- 100.5 million visitors to the public land estates managed by Parks Victoria
- 600 coastal and recreational activities undertaken by Coastcare Victoria participants

2014-15 Key outcomes

Water

- 5,153 hectares of waterway vegetation works undertaken to improve instream health
- 2,499 people engaged to increase the communities knowledge of sustainable water management
- 346 river reaches and wetlands with improved environmental condition.
